# Welcome

Welcome to our Spring update. As usual, the HSA continues its important work to promote the most humane treatment of animals during transport and slaughter, as well as striving to push for further improvements through research and development.

Alongside the activities you will read about in this newsletter, we continue to be a strong, expert voice advocating for progress and driving practical solutions, ensuring that animal welfare remains a priority in both policy discussions and industry practices.

Recently, we were one of seven animal welfare organisations invited to meet UK agriculture Ministers Baroness Hayman and Daniel Zeichner, where I shared our priorities including the need to urgently replace the use of carbon dioxide for stunning pigs with more humane alternatives, and to adopt detailed legal protections for farmed fish. We raised the same points at the All-Party Parliamentary Group for Animal Welfare (APGAW) meeting at the House of Lords, attended by Ministers, MPs, and Peers concerned with shaping animal welfare policy.

We have also just published an important report outlining the scale of the welfare challenge for wildcaught fish. Over a trillion fish are caught for food every year, and most are not humanely stunned. Our report outlines a practical roadmap to introducing humane stunning for wild fish, which could be one of the most impactful developments in animal welfare in recent decades.
